Dan Krick | Culture Matters

He has a Master's Degree in Security Management and thousands of hours of training in cybercrime, digital forensics, and network security.

Dave Brown | NDEE SLEIS Training

The NDEE is implementing an electronic reporting system called the State and Local Emissions Inventory System (SLEIS). Learn how to register in the system early in the process and gain an understanding of how you can utilize the system for reporting emissions in 2020 and beyond. Dave has worked with NDEE for over 25 years, primarily being responsible for collecting emission inventory reports from the regulated community.



Courtney Olson | Dynamic Dialogues: How to Say Something When You See Something

Spotting unsafe behavior is one thing, but addressing unsafe and unwell behavior is a whole different skill set. Integrating her health coaching and safety training experience, Courtney will share ways that you can open up conversations that will create real behavior change. Practice with interactive role-playing scenarios and then you'll be set to speak up when you see something, both on and off the job. Courtney is a Certified Health Education Specialist and ACE Certified Health Coach with a BS in Kinesiology and Health. She grew up working in the family construction company and has always been passionate about prevention.



Joseph A. Leutzinger, Ph.D. | Resiliency - Riding the Wave of Change

What is a Resilience Scale and how can it fit into a broader employee coping strategy program? See how this scale has been used by a variety of employers, how to interpret reporting outcomes, and the role middle managers play in addressing resilience. Dr. Leutzinger is the Founder of Health Improvement Solutions. He is the co-author and co-editor of several books, has given over 200 presentations in regional, national, and international forums, and authored over 35 publications. Serves on the board for the C. Everett Koop Health Project Awards and is the North American judge for the Global Centre for Healthy Workplaces.

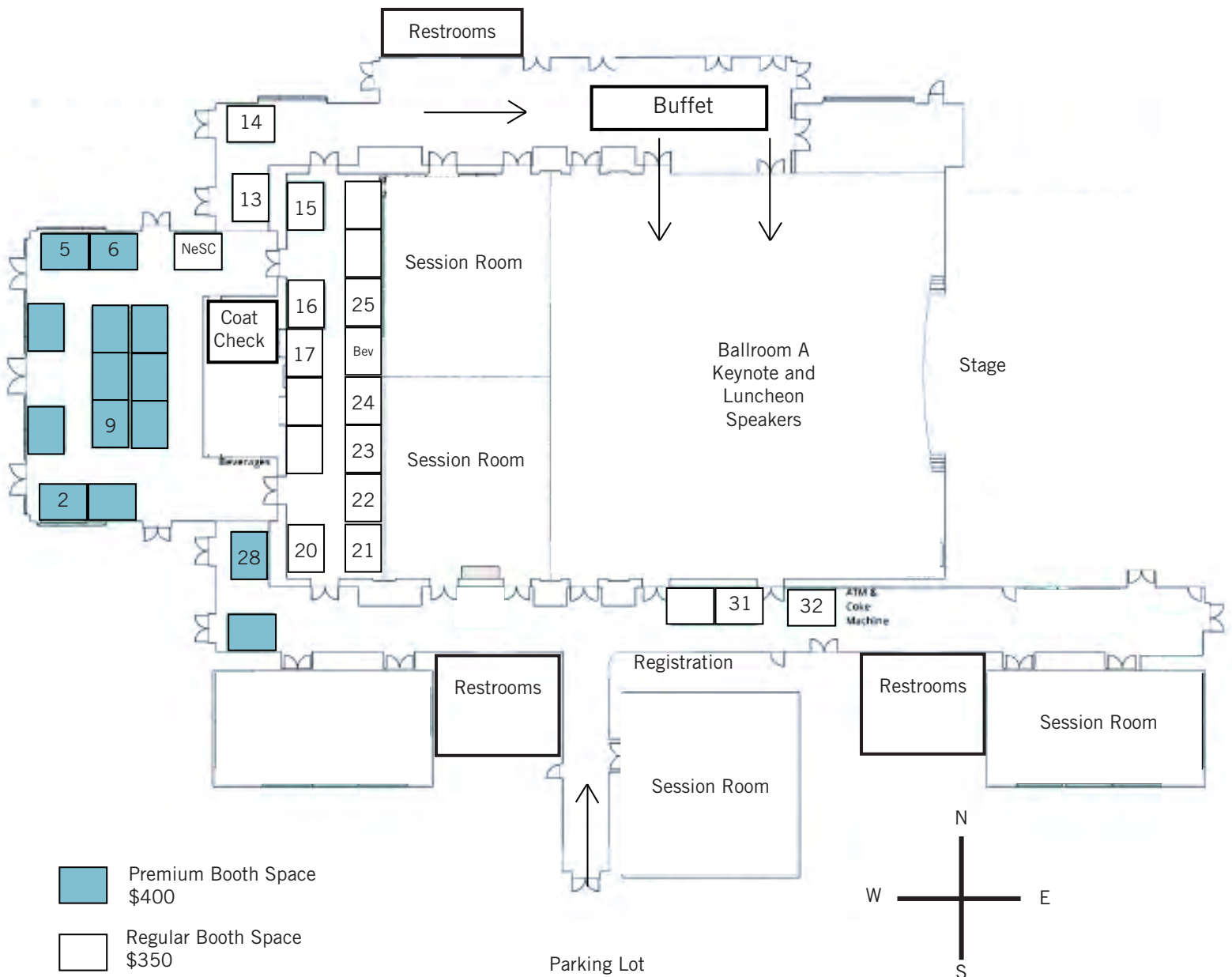


Jamie Rodriguez | Vaping At the Workplace
